Mitcham Common: Savings Schedule 2017

- 1.1 A significant proportion of the funding available for the maintenance of Mitcham Common is provided by grants from the London Boroughs of Merton, Croydon and Sutton. Unfortunately for the 2017/2018 financial year the total grant has been reduced considerably. In the case of Merton the grant figure has fallen from £48,000 in 2016/2017 to £24,000 for the current year.
- 1.2 In light of the above, the Conservators have had to make difficult decisions regarding the future maintenance of the Common. In summary, savings have had to be made in order to produce a balanced budget.
- 1.3 The Conservators have not taken this decision lightly and have advised Merton Council that if they wish the 2016/2017 maintenance schedule to be restored then they will have to fund the work and instruct their grounds maintenance contractor accordingly.
